- 1. Optical components (laser product), consumable items entitle 90 days warranty from the invoice date.
- To present a claim, Customer shall deliver the defective part for repair or replacement to a GCC America, Inc. authorized dealer.
- 3. All warranty replacement parts are under warranty from the date of purchase of the original laser engraver and not from the date of replacement. All parts purchased thereafter are under warranty for three (3) months from the date of purchase.
- 4. This limited warranty is for the replacement of defective parts only and does not cover any labor charges including, but not limited to, charges incurred for installation of replacement parts or additional fees which may be imposed by dealer or servicing agent.
- 5. This limited warranty does not extend to product damage due to misuse, abuse, negligence, fire or natural disasters. Manufacturer is not liable to the consequential damages of any above-mentioned conditions.
- 6. Customer acknowledges and agrees that Manufacturer will not be responsible for any damages which Customer may incur from delayed shipment, Product or part failure, Product or part design or production, or any other cause. Under no circumstances shall be liable for loss of profits, loss of use, or incidental, indirect, consequential, special damages.
